The Fairtrade Foundation was happy to support Fashion Revolution Week in April and their campaign, 'Who Made My Clothes?' 5 years on from the Rana Plaza tragedy, many workers, the majority of whom are women, continue to be exploited in garment supply chains. Fairtrade and Brexit

Brexit continues to be a big theme for the Fairtrade Foundation, as we seek to understand its implications for the UK's trade with developing countries, and for the particular commodities that comprise the bulk of the Fairtrade market: coffee, sugar, tea, bananas, sugar and flowers.

MPs and Peers may have read our briefings on both the **Trade and Taxation (Cross-Border Trade) Bills**, and we will prepare a further briefing, once the date for Third Reading and Report Stage is announced. We would be happy to speak with any MPs and Peers about Brexit and Fairtrade, and to share our analysis of the different ways that trade with developing countries may be affected. One aspect of trade policy requiring urgent attention is **trade governance**, especially the role of parliament in the scrutiny and approval of trade deals. Interesting papers have recently been published including by the <u>International Chambers of Commerce</u>, and we are pleased to see that a new Inquiry has been launched by the International Trade Committee. Fairtrade & the Commonwealth

In February, the Fairtrade Foundation published a report exploring opportunities for promoting and developing <u>Fairtrade across the Commonwealth</u>. Trade was much more prominent than before on the CHOGM agenda and so we were keen to see debate on the terms of trade and its impact on the poorest farmers and workers. The report included recommendations on women's economic empowerment, modern slavery and living wages and incomes, some of which were taken up at the Summit itself. Fairtrade leaders from around the world wrote an open letter which was published in The Telegraph, and we were delighted to get a mention on Thought for the Day.

This report built on evidence that our CEO gave last year to the Trade out of Poverty APPG Inquiry: 'Can the Commonwealth help developing countries trade out of poverty?' We were pleased to see that our recommendation for a 'Fair & Sustainable Trade Initiative' was proposed in their final report, and we look forward to working with them to develop this idea further. <u>Why not have a read of our blog!</u>

New Chair for the Fairtrade Foundation

The Fairtrade Foundation is delighted that **Lord Mark Price**, former Trade Minister and former Managing Director of Waitrose will be taking on the role as Chair of Trustees. Lord Price will take up his role with us in September.

Where next for the Groceries Code Adjudicator?

The Fairtrade Foundation has been part of a coalition calling for an extension of the GCA's remit to cover indirect suppliers, and we were disappointed by the government's response in February which falls short of this, despite support for an extension from the EFRA Committee. **Tackling unfair trading practices** remains a key priority and we are pleased to see positive <u>developments at an EU level</u> to strengthen the position of farmers in supply chains.
